Deposit: A 200.00 deposit is required to reserve your date. The balance is to be **paid- in- full** before departure by Cash, Money Order, or Credit Card. **No personal checks accepted at the dock.**

Mail deposit checks to **Priority Charters, LLC at 70 Gladys Drive, North Kingstown, RI 02852.**

Departure: All groups are expected to be at the boat by the agreed upon time. If an unforeseen circumstance occurs that will delay the group, a call to the captain should be made to (401)-741-5648. The captain reserves the right to cancel any charter where the party fails to arrive within one hour of the scheduled sailing time. The deposit will be forfeited at this time.

Cancellations: Cancellations due to strong winds or rough seas will be made at the dock by the captain only. When it is determined that the trip should be cancelled, an alternative day may be scheduled or the deposit will be returned. In the event that a trip is cancelled after it is started because of sea conditions, a refund will be prorated based on the hours of the trip completed. Offshore fishing trips of 10 and 12 hours duration will be downgraded to an 8 hour inshore trip if rough waters prevent the safe passage of the vessel. Fishing would then take place in protected waters close to land or in Narragansett Bay. All cancellations made by the customer less than 14 days from departure are subject to a \$200.00 service charge.

Drinking and Drugs: To prevent injury to passengers, crew, and damage to the Priority Too, the following policy has been established:

- 1.) No drugs of any kind, except for legally prescribed medications, are permitted on the boat.
- 2.) Beer and wine are the only alcoholic beverages allowed on the boat, and only for those over the age of 21.
- 3.) Persons appearing intoxicated or under the influence of drugs will not be permitted to board the boat.
- 4.) If an illegal drug is in the possession of any individual(s) or the captain determines that any individual(s) are unstable due to excessive drinking, the trip will be terminated. The balance due on the charter will be charged.
- 5.) The captain will notify the U.S. Coast Guard to remove the passenger(s) who abuse the drinking and drug policy and the trip will be terminated.
- 6.) Charter fees will not be refunded if this policy is not adhered to.

Fish: All fish caught by the anglers are theirs to keep except Swordfish, Shark, and Tuna

- 1.) Swordfish, Thresher, and Mako Shark. ½ to the anglers and ½ to the boat.
- 2.) School Tuna: Tuna less than 73 inches long belong to the anglers for a total round weight of 300 lbs. All remaining tuna will be divided equally between the anglers and the boat.

- 3.) Giant Tuna: Each individual tuna measuring 73 inches or longer will be sold with 1/3 of the money credited to the anglers.
- 4.) Free Swimming Fish: All harpooned fish belong to the boat.

Fishing Equipment: Any tackle broken or dropped because of negligence or misuse will be paid for by the customer. *(Example: Rod breaking over the edge of a gunwale).*

Anything caught or snagged other than fish belong to the boat. *(Examples: Rod and reel, anchor and chain, or line).*

Mates: A first mate is provided to help with the lines and fillet your catch, among other duties. The crew work very hard to ensure your charter is enjoyable and tipping 15% to 20% of the charter fee is customary.

Preparation Tips: Do not bring any guns or metal coolers. Allow for cool sea temperature and bring extra jackets, hat, and gloves. Wear soft rubber soles shoes of waterproof boots. Bring sandwiches already made and beverages of your choice. Call for a weather check the night before your trip especially if you are coming from out of state. Know your seasick precautions. Be prepared!

Group Organizer: It is your responsibility to inform all party members of this contract and its policies. An additional copy will be available for reading on the boat. The captain is not responsible for disseminating information except to the charter organizer.

From Connecticut and Points South: Take Rt. 95 North to Exit 92. (RI/Ct State Line) Go right on Rt. 2 East. Follow to Rt. 78 East. Turn left on Rt. 1 North. Take the Pt. Judith/Galilee Exit. Bear right at the end of ramp to intersection of Rt.108 South. Bear right on Rt.108 South. (Approx. 3 miles) Go past Fisherman's Memorial Campground and take next right at light onto Galilee Escape Road. Take a right at the end of the Escape Rd. (go approx.400') and take a quick left into the parking lot. The Priority Too is located on Dock SS in front of a two story grey building housing Captain's Tackle.

From Massachusetts and Points North: Take Rt. 95 South to Exit 9 (on left). Follow Rt. 4 South to Rt. 1 South. Continue on Rt. 1 South to the Narragansett Rt.108 exit. Go left on Rt. 108 South (approx. 3 miles) Go past Fisherman's Memorial Campground and take next right at light onto Galilee Escape Road. Take a right at the end of the Escape Rd. (go approx.400') and take a quick left into the parking lot. The Priority Too is located on Dock SS in front of a two story grey building housing Captain's Table.
